This agreement is between Hunter (Name) _____, Waterfowl Haven Hunt Club, LLC. This agreement will give full use to the hunter of any ranches or land leased by club/Waterfowl Haven Outfitters, LLC for the purpose of hunting. Access and use will be limited by club rules and procedures and can be revoked for non-compliance. All members and guests will obey state and federal hunting laws while on club properties. All members will be in charge of transportation, firearms/ammunitions, and handling/processing of game. The cost of membership/guest fees is/are 100% non-refundable.

ACKNOWLEDGEMENT AND ACCEPTANCE OF RISK:

I, _____ in consideration of being allowed to participate in any way in Waterfowl Haven Hunt Club, LLC programs, related events and activities acknowledge that Waterfowl Haven Outfitters, LLC programs, related events, and activities have inherent risks, hazards and dangers for anyone which cannot be eliminated, particularly in a wilderness environment.

I understand that risks, hazards, and dangers may include without limitation:

- The risk of injury from ammunition and being shot from other guns;
- The risk of handling firearms and or being near others that have firearms in their possession;
- The risk of ear damage from noise;
- High, fast moving water, deep water, uncertain bottoms, ice and mud;
- Inclement weather conditions causing hazardous conditions;
- Walking in rugged country and encountering wildlife, insects, plants, and uneven and unpredictable terrain;
- Possible dangerous materials in all areas of blinds, pits and club areas;
- Physical stress;
- Unclear property boundaries and it is hunter responsibility not to trespass.

I, _____ understand and acknowledge that the programs, related events and activities which I am voluntarily engaging in as a participant and/or observing bear certain known risks and unanticipated risks which could result in injury, paralysis, death, illness, disease, either physically or mentally, or damage to myself, my property, or to spectators or third parties. I expressly agree, covenant, and promise to accept and assume all responsibility and risk of injury, paralysis, death, illness, disease, or damage to myself or my property arising from participating in Waterfowl Haven Outfitters, LLC programs, related events and activities.

I also agree to pay for any damages, injuries or losses I cause to others, (including attorney fees and costs) due to my negligent actions. Such damages, injuries or losses include, but are not limited to, damage to personal or real property. My participation in Waterfowl Haven Outfitters, LLC programs, related events and activities is purely voluntary; no one is forcing me to participate and I elect to participate in spite of the known and unknown risks.

I hereby expressly waive and release any and all claims, now known or hereafter, against the Waterfowl Haven Hunt Club, LLC and their officers, directors, employees, agents, affiliates, shareholders/ members, insurers, successors and assigns (collectively, "Releasees"), arising out of or attributable to my participation in, or observation of, Waterfowl Haven Outfitters, LLC programs, related events and activities, whether arising out of negligence or otherwise. I covenant not to make or bring any such claim against the Releasees, and forever release and discharge the Releasees from liability under such claims.

With the signing of this contract I acknowledge I have read the above agreement and understand that I am bound by the terms thereof by placing my signature hereon.
